- 1. The House assembled at Thirty Minutes past Two O'clock in the afternoon
- **2.** The Proceedings were opened with Prayer
- **3. Presiding -** The Honourable Speaker

4. LACK OF QUORUM

There being no Quorum present to commence business, the Honourable Speaker ordered that the Quorum Bell be rung for Ten minutes; and

And Quorum having been attained within the Ten minutes, business commenced.

5. COMMUNICATION FROM THE CHAIR

The Rt. Honourable Speaker issued the following Communication to the House

Resumption of Sittings for the Third Part of the Third Session

"Honourable Members, I wish to welcome you back to the House for the Third and last Part of the Third Session of the 13th Parliament. I note that the recess was a working break for most Committees, given the vetting of nominees proposed for appointment to various State offices and other priority matters that were referred to Committees before and during the recess period. Nevertheless, it is my hope that you managed to spend some valuable time with your families and constituents and are now rejuvenated and ready to tackle the business that lies ahead.

Honourable Members, as we resume our sittings, the House is expected to transact several priority business, some of which is already before Committees. These include consideration of nominees for appointment as Inspector-General of the National Police Service, and the Director-General of the Competition Authority, which have statutory timelines. Additionally, the House shall consider key Bills that are at various stages of consideration, including four (4) National Assembly Bills and two (2) Senate Bills that are currently under Mediation Stage. The Bills are—

(a) the **Sugar Bill (National Assembly Bill No. 34 of 2022)**. With regard to this Bill, you will recall that on 1st August 2024, this House considered and rejected some of the Senate amendments to the Bill, necessitating mediation on the Bill. Consequently, I proceeded to appoint nine (9) Members to the Mediation Committee and designated the **Hon. Emmanuel Wangwe, CBS, MP**, who is also the sponsor of the Bill, as the Co-Chairperson. In reference

to this, I have since received communication from the Senate designating the following Senators to the Committee—

- (1) Sen. James Murango, MP;
- (2) Sen. Richard Onyonka, EBS, MP;
- (3) Sen. David Wafula, MP;
- (4) Sen. Catherine Mumma, MP;
- (5) Sen. Samson Cherarkey, MP;
- (6) Sen. Agnes Muthama, MP; and
- (7) Sen. Esther Okenyuri, MP.

Honourable Members, now that the Senate has appointed Members to the Mediation Committee, the Committee is fully constituted and should embark on attempting to develop a mediated version of the Bill in accordance with the provisions of Article 113 of the Constitution.

- (b) the **National Rating Bill (National Assembly Bill No. 55 of 2022)** is another Bill undergoing mediation process. The Bill was referred to a Mediation Committee that is co-chaired by the **Hon. Joash Nyamoko, MP**, the Chairperson of the Departmental Committee on Lands.
- (c) The third Bill under mediation is the **Water (Amendment) Bill (National Assembly Bill No. 33 of 2023)**. The Mediation committee is co-chaired by the **Hon. Kangogo Bowen, MP**, Chairperson of the Departmental Committee on Blue Economy, Water and Irrigation.
- (d) the **Conflict-of-Interest Bill (National Assembly Bill No. 12 of 2023)** sponsored by the Leader of the Majority Party is another Bill awaiting mediation. The Bill was referred to a Mediation Committee that is co-chaired by the **Hon. George Murugara, CBS**, **MP**, Chairperson of the Departmental Committee on Justice and Legal Affairs.
- (e) **the Employment (Amendment) Bill (Senate Bill No. 11 of 2022)** which is sponsored by Sen. Samson Cherarkey, MP is the fifth Bill also awaiting to be processed through Mediation under Article 113 of the Constitution. The Bill was lost at Second Reading on 5th March 2024. It was referred to a Mediation Committee that is co-chaired by the **Hon. Eric Muchangi, MP**, Chairperson of the Departmental Committee on Labour.
- (f) the Natural Resources (Benefit Sharing) Bill (Senate Bill No. 6 of 2022) which is sponsored by Sen. Danson Mungatana, MP, was lost at Second Reading on 12th March 2024, is also awaiting Mediation. It was referred to a Mediation Committee that is co-chaired by the **Hon. David Gikaria, CBS, MP**, Chairperson of the Departmental Committee on Environment, Forestry and Mining.

Honourable Members, Article 113 provides that a Mediation Committee must report back to both Houses with an agreed version of the Bill, or lack thereof, within thirty days of its establishment. I urge co-chairpersons and the mediation teams representing the House to expedite consideration of the six (6) Bills for their progression to the next stage. This will bring a timely conclusion to the bicameral processes relating to the Bills.

Further, Hon. Members, the House is expected to consider Senate amendments, if any, to three (3) Bills passed by the House before the recess, that are meant for financing of our counties. These are the Division of Revenue (Amendment) Bill, 2024, the County Allocation of Revenue Bill, 2024 and the County Government Additional Allocations Bill, 2024.

On behalf of the Leadership of the House and indeed on my own behalf, may I reiterate our readiness and availability to support the House, its committees, and its Members, both individually and collectively, to discharge the great public duty bestowed on us. I therefore urge each one of you to diligently undertake your national duty, appreciating that your dedication to your constituents and the nation, is paramount.

Honourable Members, you may also recall that I had informed the House of the temporary suspension of the Question Time to afford the newly appointed Cabinet Secretaries time to familiarize themselves with their respective dockets. Noting the passage of time since the Cabinet Secretaries assumed their new responsibilities, and following consultations with the Leader of the Majority Party, I now wish to inform the House that we will resume Question Time starting tomorrow, Wednesday 18th September, 2024.

In this regard, and as indicated in the Notice of Questions in today's Order Paper, the Cabinet Secretary for Education is scheduled to appear in plenary tomorrow afternoon to respond to, among other matters, the progress in implementing the commitments made during the Member's *Kamukunji* held on Tuesday, 20th August 2024 regarding the *New Higher Education Funding Model*.

Additionally, the Cabinet Secretary shall also address other issues of concern in the education sector including incidents of school fires and unrest across the country, and the general safety of learners. Particular attention shall be paid to the tragic incident at the *Hillside Endarasha Academy* in Nyeri County, where we unfortunately lost twenty-one (21) learners. This incident represents a tragic loss to the nation and the House must be fully apprised of its cause and the remedial measures proposed to be taken by the Ministry. On behalf of the House and indeed on my own behalf, I wish to extend our deepest condolences to the affected families.

Having said that **Honourable Members**, May I therefore request that we all stand to observe a minute of silence in honour of the young departed souls. May their souls rest in eternal peace. I thank you!"

Honourable Members, the Message conveys that the Senate, by a resolution passed on 20th August 2024, approved the appointment of **Mr. Douglas Kanja Kirocho** as the Inspector-General of the National Police Service.

Honourable Members, you will recall that the approval hearings for the nominee for Inspector-General of the National Police Service were conducted jointly by the relevant Committees of the two Houses of Parliament in line with established practice and in fulfilment of the provisions of Article 245(2)(a) of the Constitution.

Accordingly, the Departmental Committee on Administration and Internal Security is expected to table the Joint Report on the vetting of the nominee this afternoon. Consequently, the House Business Committee has scheduled the said Report for consideration by the House tomorrow, Wednesday, 18th September 2024, during the morning sitting.
