TUESDAY, OCTOBER 08, 2024 AT 2.30 P.M.

1. The House assembled at Thirty Minutes past Two O'clock.
2. The Proceedings were opened with Prayer.
3. **Presiding** – the Honourable Speaker.
4. **MESSAGE**

The Speaker issued the following Message from the Senate –

Decision of the Senate on Two Bills

“Honourable Members, pursuant to the provisions of Standing Order 41(4), I wish to report to the House that I have received two Messages from the Senate regarding its decision on two Bills, namely the Equalisation Fund Appropriation (No.2) Bill (Senate Bill No. 30 of 2023) and the Division of Revenue (Amendment) Bill (National Assembly Bill No. 38 of 2024).

Honourable Members, the First Message conveys that, on Tuesday, 17th September 2024, the Senate considered and **rejected** the National Assembly’s amendments to the Equalisation Fund Appropriation (No.2) Bill (Senate Bill No. 30 of 2023). You will recall that, this House considered and passed the Bill with amendments on 13th June 2024. Thereafter, I referred the Bill back to the Senate for reconsideration in accordance with the provisions of Article 112(1)(b) of the Constitution.

Honourable Members, the decision of the Senate on the National Assembly’s amendments to the Equalisation Fund Appropriation (No.2) Bill (Senate Bill No. 30 of 2023) effectively commits the Bill to a Mediation Committee pursuant to the provisions of Article 112(2)(b) of the Constitution.

Consequently, the Speaker of the Senate has appointed the following Senators to the Mediation Committee on the Bill–

- (1) Sen. Joe Nyutu, MP;
- (2) Sen. Mohamed Abass Sheikh, MP;
- (3) Sen. (Prof.) Margaret J. Kamar, EGH, MP;
- (4) Sen. Tabitha M. Mutinda, MP;
- (5) Sen. Daniel Maanzo, MP;
- (6) Sen. Beatrice Ogola, MP; and
- (7) Sen. Faki Mohamed Mwinyihaji, MP.

Honourable Members, in order to fully constitute the Mediation Committee on the Bill, the National Assembly is required to appoint seven (7) Members to sit in the Committee. I therefore call upon the Majority and Minority Leadership of the House to nominate Members to represent the National Assembly in the Mediation Committee by **7.00 p.m. today**, Tuesday, 8th October 2024. I will then communicate to the House tomorrow the National Assembly Members appointed to this Mediation Committee, to ensure timely commencement of the mediation process.

Honourable Members, the Second Message conveys that on Thursday, 3rd October 2024, the Senate considered and passed the Division of Revenue (Amendment) Bill (National Assembly Bill No. 38 of 2023) **with amendments**.

You will also recall that, on 7th August 2024, this House considered and passed the Bill with amendments, following which I referred the Bill to the Senate for consideration in accordance with the provisions of Article 110(4) of the Constitution. The Senate has now referred the Bill back to the National Assembly for reconsideration.

Honourable Members, with respect to the Division of Revenue (Amendment) Bill, 2024, I direct the Clerk to circulate the Senate amendments to the Bill to all Members. Thereafter, the amendments will stand referred to the **Budget and Appropriations Committee**.

I urge the Committee to expedite consideration of the Senate's amendments and report back to the House on **Tuesday, 15th October 2024**. Conscious that the House is to scheduled proceed on a short recess next week, I direct that the matter be prioritized for consideration on the same day. I hasten to remind Members that conclusion of the Division of Revenue (Amendment) Bill, 2024 will pave way for reconsideration of the County Allocation of Revenue Bill, 2024 which was referred back to the Senate under Article 115 of the Constitution by H.E. the President following rejection of the Finance Bill, 2024. This will facilitate disbursement of the requisite funds to our county governments, and avoid further stalling of operations of the devolved units. The House is accordingly guided. I thank you!"

5. **SPECIAL MOTION – PROPOSED REMOVAL BY IMPEACHMENT OF H.E. RIGATHI GACHAGUA, EGH, DEPUTY PRESIDENT OF THE REPUBLIC OF KENYA**

Motion made and Question proposed—

THAT, pursuant to the provisions of Articles 145 and 150(1)(b) and (2) of the Constitution and Standing Orders 64 and 65, this House resolves to remove from office, by impeachment, H.E. Hon. Rigathi Gachagua, EGH, the Deputy President of the Republic of Kenya on the following grounds—

1. Gross violation of Articles 10(2)(a), (b) and (c); 27(4), 73(1)(a) and (2)(b); 75(1)(c), 129(2) of the Constitution and Article 147(1), as read together with Article 131(2)(c) and (d) of the Constitution:

THAT, H.E. the Deputy President has persistently made utterances threatening to discriminate, exclude, and unlawfully deny sections of the people of Kenya and regions of the Republic of Kenya equal opportunities for public service appointments and allocation of public resources;

2. Gross violation of Articles 147(1) and 152(1) of the Constitution by undermining the President and the Cabinet and the effective discharge of the national government's executive mandate:

THAT, H.E. the Deputy President has made unilateral public statements inconsistent with policy positions collectively adopted by the Government and contradicted the

President on critical matters of governance and the exercise of the President's function as a symbol of national unity;

3. Gross violation of Articles 6(2), 10(2)(a), 174, 186(1), 189(1) and the Fourth Schedule to the Constitution by undermining Devolution:

THAT, H. E. the Deputy President interfered with the running of Nairobi City County Government by inciting citizens against lawful directives of the County Government on the planning and relocation of markets and publicly disparaging the leadership of the County Government and its decisions;

4. Gross violation of Article 160(1) of the Constitution on the Institutional and Decisional Independence of Judges:

THAT, H.E. the Deputy President has undermined the institutional and decisional independence of a judge through public attacks on a judge of the High Court of Kenya and falsely threatening to file a petition for the removal of the said Judge in a matter in which he was a party;

5. Gross violation of Articles 3(1) and 148(5)(a) of the Constitution on the fidelity to the Oath of Office and Allegiance:

THAT, H.E. the Deputy President breached his Oath of Office and Allegiance on account of the utterances and actions attributed to the Deputy President under Grounds (1), (2), and (3);

6. Serious reasons to believe that H.E. the Deputy President has committed crimes under sections 13(1)(a) and 62 of the National Cohesion and Integration Act:

THAT, H.E. the Deputy President has persistently made inflammatory, reckless, inciteful public utterances over the last two years in contravention of the law;

7. Serious reasons to believe that H.E. the Deputy President has committed gross economic crimes under sections 45(1), 46, 47(A)(3) and 48(1) of the Anti-Corruption and Economic Crimes Act and sections 2, 3, 4, and 7 of Proceeds of Crime and Anti-Money Laundering Act:

THAT, H.E. the Deputy President has committed gross economic crimes, namely, conflict of interest, abuse of office, and conspiracy to commit crimes under sections by inexplicably amassing property estimated at Kshs. 5.2 billion that is incompatible with his known legitimate income; and by trading with the Office of the Deputy President through proxies;

8. Serious reasons to believe that H.E. the Deputy President has committed crimes by continuously misleading members of the public through false, malicious, divisive, and inciteful remarks that are contrary to the provisions of section 132 of the Penal Code and section 29 of the Leadership and Integrity Act;

9. Gross misconduct that is incompatible with the high calling and dignified status of the Office of the Deputy President, a member of the Cabinet and the National Security Council. H.E. the Deputy President has publicly attacked and undermined the work of the National Intelligence Service and its Officers;

10. Gross misconduct by openly or publicly insubordinating the President, who is the Head of State and Government; and

11. Gross misconduct by persistently bullying State and public officers.

(Hon. Mwengi Mutuse – 08.10.2024)

Debate interrupted on Tuesday, October 8, 2024 (Morning Sitting) resumed;

Pursuant to the resolution of the House of October 2, 2024, and in accordance with Standing Order 67(b)(ii) (*Right to be heard*), His Excellency Hon. Rigathi Gachagua, EGH, the Deputy President of the Republic of Kenya, was given an opportunity to respond to the grounds raised in the impeachment motion;

Thereupon, debate resumed;

Mover replied;

The Hon. Speaker directed that the division bell be rung for five minutes and that a Roll Call Division be undertaken pursuant to the provisions of Standing Order 72(2);

Hon. Zaheer Jhanda and Hon. Jared Okello were nominated as the Vote Tellers for “Ayes”;

6. COMMUNICATION FROM THE CHAIR

Upon conclusion of the Division, the Hon. Speaker issued the following Communication:

On the Decision of the National Assembly on the Special Motion on the Proposed Removal from Office, by Impeachment of H.E. Rigathi Gachagua, the Deputy President of the Republic of Kenya

“Honourable Members, as I had guided the House earlier in today’s Sitting, Article 145(2) of the Constitution sets a threshold of at least two thirds of the Members of the National Assembly to vote in support of a Special Motion for proposed removal, by impeachment of the Deputy President of the Republic, for such Motion to be carried.

According to the results of the Division on the Special Motion, which I have just declared, a total of 281 Members of this House, being more than two thirds of the Members of the National Assembly, have voted in support of the Special Motion. Article 145(2)(a) of the Constitution provides that—

*“If a motion under clause (1) is supported by at least two thirds of all Members of the national Assembly, the Speaker shall inform the Speaker of the Senate of the resolution **within two days.**”*

In this regard, I will proceed to discharge the singular duty placed on me by Article 145(2)(a) of the Constitution, being to notify the Speaker of the Senate of the resolution of the National Assembly. The Clerk is directed to prepare the necessary documentations to accompany the Resolution.

Honourable Members, the House will resume tomorrow, Wednesday, 9th October 2024 at 9.30 am, to resume consideration of regular business as scheduled by the House Business Committee. I thank you!”

And the time being twenty one minutes past Nine O’clock, the Honourable Speaker interrupted the proceedings and adjourned the House without Question put pursuant to the Standing Orders.
