As Members are aware, the advertisements published today inviting submission of views and notifying the public of hearings on the Special Motion list all 290 constituencies and indicate that the exercise is to be coordinated from 47 County Venues/Collection Centres across the country.

Arising from the Members' Briefing held earlier today, I wish to clarify that the Public Participation Programme additionally contemplates the collection of views at the constituency level.

In this regard, I confirm that Officers of the Clerk shall be present to assist in the collection and compilation of Views for onward transmission to the Office of the Clerk through the respective collection/compilation centres specified in the published advertisements.
